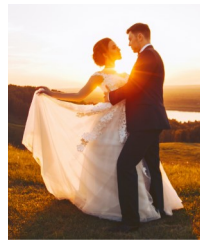

### EXHIBITOR REGULATIONS

**BOOTH SPACE:** Each exhibitor will receive a 10'x20' area to set up their booth. They will be provided with a table and two chairs. Vendors are invited to decorate their booths as they wish. All décor should be tasteful and keeping with the intent of the Expo. They may bring furniture such as shelving, additional tables and/or chairs, as needed. Since most of the booths will be outside, exhibitors are encouraged to bring tents or canopies. Booths must be staffed for the entire event. Helium balloons can be dangerous to the horses on the property. Exhibitors are discouraged from using them.

**FOOD AND BEVERAGES:** A hospitality suite will be set up for exhibitors which will include a light lunch and beverages. Food and beverages are not to be sold at any booth. Small, wrapped candies as "giveaways" will be allowed at all booths.

**BOOTH SET UP AND TAKEDOWN:** The gates will be opened all day Friday, March 18<sup>th</sup> for vendor set up. We ask that all booths be completed by 9:00 am on March 19<sup>th</sup> so unsightly trash can be removed. Takedown begins no earlier than 4:30pm on Saturday, March 19<sup>th</sup>. The property gates will be open on Sunday, March 20<sup>th</sup> beginning at 9:00 should vendors need additional time to remove large items brought in for the expo. They will be locked Saturday night at 8:00 pm.

**SALES:** Exhibitors are responsible for collecting and submitting all applicable sales tax.

**PRIZES:** Exhibitors are encouraged to have a small giveaway at their booth or to make a contribution to the attendees gift bags. It is also suggested each booth have a drawing for a gift. It could be something as simple as a small gift certificate, but will allow exhibitors to gather contact information for future reference.

**PROPERTY REGULATIONS:** It is understood that exhibitors shall not deface the premises in anyway. The Barn at Hidden Oaks is a working Arabian Horse Farm. At no time is anyone allowed to enter any of the pastures.

**INSURANCE:** MC Bridal Expo, LLC and The Barn at Hidden Oaks are not responsible for loss or damage to the exhibitors' property. In the event and exhibitor desires to have goods, samples or other property brought to the property insured against loss due to any cause, it is the responsibility of the exhibitor to secure such insurance at his own expense.

**LIMITATION OF LIABILITY:** The exhibitor agrees to hold MC Bridal Expo, LLC, The Barn at Hidden Oaks and any persons associated with each harmless from any and all claims, demands, suits, liabilities, damages, loss, costs, attorney fees and expenses of whatever kind or nature which might arise out of any actions or failure to act of the exhibitor or anyone associated with said exhibitor, but not limited to claims of damage or loss to property or harm or injury to a person or persons.

**EXPO CANCELLATION/RESCHEDULING:** If inclement weather necessitates the cancellation of the Expo from the original date, exhibitors will be given the option of a refund of the booth cost or taking part in the rescheduled event. MC Bridal Expo, LLC is not responsible for any other cost incurred by the exhibitor.
